**ENTRY FEES:** Each entry must be accompanied by the stipulated entry fee. Please make checks or money orders payable in US funds to BUTLER CAT FANCIERS. The entry clerk will phone *collect* to clarify any entries. **\$25.00 CHARGE ON ALL RETURNED CHECKS!** Entries submitted within 10 days of the show and paying at the door pursuant to Show Rule 4.07, **MUST PAY IN CASH AT CHECK-IN.**

**CLOSING DATE:** November 4<sup>th</sup>, 2009, at NOON, or when 225 entries have been received. No veterinarian inspection prior to benching. Healthy, infection-free cats are expected. Cats & kittens should be inoculated against feline enteritis, feline rhinotracheitis, calici viruses, rabies, tested for & found negative for FeLV before entry. Pennsylvania State Law requires rabies vaccinations. All claws of all entries must be clipped. No kittens under 4 months of age shall be permitted in the showhall.

**CHECK-IN:** 7:30-8:30 am. Cats not checked in by 8:45 will be marked absent. **Judging will begin at 9:00 am.** Butler Cat Fanciers, Inc. will take reasonable care of cats & property, but is not liable for loss or damage. All Championship, Premiership & registered Kittens will be scored for CFA National & Regional awards. Show rules strictly enforced. To obtain show rules, contact CFA, 1805 Atlantic Avenue, P.O. The club reserves the right to add judges not named in this flyer to judge non-Championship & non-Premiership classes. The club will provide litter sufficient for each entry. Cage size is aprx. 22 x 22 x 22". Showhall will be heated or air-conditioned, as appropriate. No smoking is allowed in the areas where cats are benched & where judging is held. People food will be available.
